Recognition Order

WHEREAS in terms of Section 14(1)/Section of the NCTE Act, 1993 NARMADA SHIKSHA MAHAVIDYALAY, D.B. VALLABII DAS PALACE, HANUMAN TAL, JABALPUR, Madbya Pradesh has submitted an application (Code No.- APW94231/225943) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting B.ED course with an annual intake of 100 students on 29.12.2006.

- AND WHEREAS in its 123rd meeting held on 28-29 "Juy,2009 the Western Regional Committee after
 considering the report of the visiting team as well as other relevant material furnished by the applicant institution
 decaded to refuse recognition on the institution for ILED course and accordingly the Refusal order na. WKC:
 APWB4419/223517/123rd /2009/59340 dt. 19.08,2009 was issued to the institution.
- AND WAHEREAS the correspondent, NARMADA SHIKSHA MAHAVIDYALAY, D.B. VALLABH DAS PALACEHANUMAN TAL, JABALPUR, Madhya Pradesh has preferred an appeal to NCTI. New Delhi against tis, decision of WRC refusing recognition under section 18 of the NCTE Act, 19993 against the said Order.
- AND WHEREAS having considered the oral submission by the representative of the institution, the written
 representation, the record of the case and V.T. Report, the Appellate Authority decided to reverse the order of NCTE.
 WRC. Accordingly, the appeal was accepted with direction to WRC to grant recognition to the institution manadiately.
- NOW, ITTEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1995, and as per the NCTE. New Delhi Order No.F.No. 89-1018/2009/Appeal-A5762 Dated: 06.11.2009 the Western Regional Committee hereby grants recognition / permission to NARMADA SHIKSHA MAILAVIDYALAY, D.B. VALLABII DAS PALACE, HANUMAN TAL, JABALPUR, Madhya Pradesh for conducting B.E.D. course from academic session 2009-2010 of SEC of 1 year duration with an annual intake of 100 under clause 7(11) of NCTER Recognition Norms & Procedure.) Regulation 2007.
- 6. The admission of student shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of student shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011.
- The recognition/ permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is felfalled as per calendar of the University /Affiliating Body.
- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve final account into a joint account to be operated along with an officer of the Westera Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 10 The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

- 11. The institution shall ensure that the required number of academic staff for conducting the course is always in position
- 12 Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 14. The institution shall maintain & update its Web-site as per provisions of NCTF Regulations and always following as mandatory disclosure:
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars.
 - (iii) Staff Profile.
 - (iv) Recognition letter.
 - (v) Information for having fulfilled the norms & standard and other required conditions
- 15. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 16. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Feacher Education, Hans Bhawan, Wing-II, I, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
